#### RESOLUTION NO. CW 410-2025

RESOLUTION POSTPONING THE PUBLIC BIDDING OF THE PROVINCIAL INFRASTRUCTURE PROJECTS RE-SCHEDULED ON 24 JULY 2025 TO 28 JULY 2025 OR THE NEXT WORKING DAY IF THERE WILL BE WORK SUSPENSION

**WHEREAS**, the Rizal Provincial Government, through the Rizal Provincial Bids and Awards Committee (RPBAC), advertised an Invitation to Bid (ITB) for the procurement of provincial infrastructure projects from the period of 4 July to 10 July 2025;

**WHEREAS**, the publication covers the procurement of thirty-five (35) provincial infrastructure projects with schedule of bid opening/public bidding on 22 July 2025;

**WHEREAS,** in the Invitation to Bid (ITB) for the said public biddings, deadline of submission of bids was set at eleven o'clock in the morning (11:00 a.m.) on 22 July 2025;

WHEREAS, due to the inclement weather and as per Memorandum Circular No. 89 issued by the Office of the President on 21 July 2025 suspending work in government offices and classes at all levels in Metro Manila, Pangasinan, Tarlac, Zambales, Bataan, Pampanga, Bulacan, Cavite, Batangas, Rizal and Occidental Mindoro, the Rizal Provincial Government, through the Rizal Provincial Bids and Awards Committee (RPBAC) resolved to postpone the public bidding of the aforementioned infrastructure projects and move the deadline of submission of bids and opening of bids to 24 July 2025 through RPBAC Resolution No. CW 409-2025 issued on 22 July 2025;

WHEREAS, due to the <u>inclement weather and as per Memorandum</u> Circular No. 91 issued by the Office of the President on 23 July 2025 suspending work in government offices and classes at all levels in several provinces and cities, including the Province of Rizal, it is deemed best to postpone the public bidding and deadline of submission of bids of the aforementioned infrastructure projects, re-scheduled on 24 July 2025;

**WHEREAS,** there is already a differently scheduled public bidding for provincial infrastructure projects on 25 July 2025;

NOW THEREFORE, We the members of the Rizal Provincial Bids and Awards Committee (RPBAC) for and in consideration of the foregoing, hereby resolved, as it is hereby RESOLVED, to postpone the public bidding and deadline of submission of bids of the aforementioned infrastructure projects, rescheduled on 24 July 2025, be moved to 28 July 2025 at 1:00 p.m. and 11:00 a.m. respectively or the next working day if there will be work suspension on the said date;

**RESOLVED FURTHER,** that copies of this Resolution be furnished to the Philippine Government Electronic Procurement System (PhilGEPS), and to the State Auditor, Commission on Audit (COA) of this Province, and be published at the Province of Rizal website and bulletin board.
