**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Procurement of Janitorial Services for Ynares Center Montalban and Ynares Rescue Center Montalban. in the Philippine Government Electronic Procurement System (PhilGEPS), and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, RPHS - Morong and RPHS - Angono for the period covered 04 July 2025 to 23 July 2025, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is Two Million One Hundred Thousand Pesos (P 2,100,000.00)

**WHEREAS**, the Procurement of Janitorial Services was on a per lot basis;

**WHEREAS**, in response to the said advertisement, One (1) supplier/contractor purchased bid documents and that is, Cleanermen, Inc;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 28 July 2025 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;


**NOW THEREFORE, WE**, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


1. **TO DECLARE CLEANERMEN, INC.** as the bidder with the single calculated and responsive bid for the Procurement of Janitorial Services, to wit:

  - b.) Ynares Center Montalban in the amount of **₱ 21,208.90** - Monthly Rate per Personnel (Day Shift) and **₱ 16,420.11** - Monthly Rate per Personnel (With Event).

**UNANIMOUSLY APPROVED** this 28<sup>th</sup> day of July 2025 at the City of Antipolo, Province of Rizal.


