WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Regulated Drugs for the use of hospitals under Rizal Provincial Hospital System (RPHS) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 11 July 2025 to 30 July 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is One Million Five Hundred Two Thousand Five Hundred Fifty Pesos (₱ 1,502,550.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, EAON Enterprise;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 31 July 2025 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following:

UNANIMOUSLY APPROVED this 5th day of August 2025, at the City of Antipolo, Province of Rizal.


