

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING
APPROVAL**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Trophies and Medals for distribution to different barangays and schools within the Province of Rizal which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 20 August 2025 to 09 September 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is One Million Six Hundred Seventy Thousand Pesos (₱ 1,670,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Gillean Trading;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 10 September 2025 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following:

1. **TO DECLARE GILLEAN TRADING** as the bidder with the single calculated and responsive bid for the **Supply and Delivery of Trophies and Medals** in the amount of **One Million Six Hundred Thirty Four Thousand Pesos (₱ 1,634,000.00);** and,
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
