**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of three (3) units Patrol Motorcycle for Peace and Order Program which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong, RPHS- Angono for the period covered 17 January 2025 to 5 February 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is One Million Eight Hundred Sixty Thousand Pesos (₱ 1,860,000.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, K Servico Trade, Inc.;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 06 February 2025 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

RESOLVE as it is hereby RESOLVED:




