

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING
APPROVAL****Resolution No. GS2025-055
Series of 2025.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Mini Dump Truck which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 23 July 2025 to 11 August 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is Four Million One Hundred Thousand Pesos (₱ 4,100,000.00);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid namely **MCX International Inc.** and **Autokid Subic Trading Corp.**;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 12 August 2025. MCX International Inc. was able to satisfy the requirements to participate. However, Autokid Subic Trading Corp. failed to submit its Income Tax Return 2023 and Financial Statement 2023 from the bid opening. Hence, applying the pass/fail criteria, was declared disqualified to participate in the activity;

WHEREAS, the bid proposal of MCX International Inc. was found to be substantially complying, subsequently, bid evaluation was conducted and resulted as follows:

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that MCX International Inc. appears to be the single calculated and responsive bid for the Supply and Delivery of Mini Dump Truck, in the amount of Four Million Forty Eight Thousand Five Hundred Pesos (₱ 4,048,500.00);

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by MCX International, Inc., the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:



2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


