WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, MNJ Trading;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 17 February 2025 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

1EREAS, upon careful examination, validation and verification of the requirements, to ane technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- 1. TO DECLARE MNJ TRADING as the bidder with the single calculated and responsive bid for the Purchase of Sporting Goods and Equipment in the amount of Four Million Eight Hundred Ninety Five Thousand Six Hundred Sixty Two Pesos (**P** 4,895,662.00);
- 2. That NO BID was received for Item Nos. 21, 30, 42 and 60 (4 line items) amounting to ₱ 246,000.00 has been referred to the BAC members and thereafter decided to cancel the said items, pursuant to the provisions of RA 9184.
- 3. TO RECOMMEND for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
