WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Office Supplies for the use of Rizal Provincial Government for 2<sup>nd</sup> Semester of 2025 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 13 June 2025 to 02 July 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is Eight Million One Hundred Twenty Nine Thousand Four Hundred Ninety Three Pesos and Fifty Centavos (\$\P\$ 8,129,493.50);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid, namely, MNJ Trading and Igglio Consumer Goods Trading;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 03 July 2025 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, Igglio Consumer Goods Trading submitted quotation for Item Nos. 1-11, 14-37, 42-45, 55-64, 69-80, 85-112 and 114 in the amount of Seven Million Two Hundred Eighty Eight Thousand Two Hundred Thirty Three Pesos and Fifty Five Centavos (₱ 7,288,233.55), and MNJ Trading submitted quotation for Item Nos. 12, 13, 23, 24, 34-42, 46-59, 65-68, 72-75, 81-84, 92-97, 99-102, 104, 113 in the amount of Seven Million Eighty Nine Thousand Nine Hundred Twenty Pesos (₱ 7,089,920.00);

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, Igglio Consumer Goods Trading's quotation for Item Nos. 1-11, 14-22, 25-33, 43-45, 60-64, 69-71, 76-80, 85-91, 98, 103, 105-112, 114 in the amount of One Million Twenty Seven Thousand Eight Hundred Twenty One Pesos and Five Centavos (₱ 1,027,821.05), and MNJ Trading's quotation for Item Nos. 12, 13, 23, 24, 34-42, 46-59, 65-68, 72-75, 81-84, 92-97, 99-102, 104, 113 in the amount of Seven Million Eighty Nine Thousand Nine Hundred Twenty Pesos (₱ 7,089,920.00) appears to be the lowest calculated bid per item submitted of each bidder (Bid Evaluation is hereto attached for ready reference);

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED the following, and:

## 1. TO DECLARE:

- MNJ TRADING's quotation for Item Nos. 12, 13, 23, 24, 34-42, 1.1 46-59, 65-68, 72-75, 81-84, 92-97, 99-102, 104, 113 in the amount of Seven Million Eighty Nine Thousand Nine Hundred Twenty Pesos (₱ 7,089,920.00); and,
- IGGLIO CONSUMER GOODS TRADING's quotation for Item 1.2 Nos. 1-11, 14-22, 25-33, 43-45, 60-64, 69-71, 76-80, 85-91, 98, 103, 105-112, 114 in the amount of One Million Twenty Seven Thousand Eight Hundred Twenty One Pesos and Five Centavos (**P** 1,027,821.05);

as the lowest calculated and responsive bid for the supply and delivery of such office supplies.

2. TO RECOMMEND for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
