WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Heavy Duty Tent which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 23 July 2025 to 11 August 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is Six Million Nine Hundred Thousand Pesos (₱ 6,900,000.00);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted their bids, they are, MNJ Trading and Fabrimetrics Phils, Inc;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 12 August 2025 and thereafter found to be eligible;

WHEREAS, the bidders' financial component of the bid was found to be substantially complying;

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that MNJ Trading appears to be the lowest calculated bid for the Supply and Delivery of Heavy Duty Tent, in the amount of Five Million Six Hundred Two Thousand Eight Hundred Pesos (₱ 5,602,800.00);

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

Now THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED the following, and:

1. **TO DECLARE MNJ TRADING** as the bidder with the lowest calculated and responsive bid for the **Supply and Delivery of Heavy Duty Tent** in the amount of **Five Million Six Hundred Two Thousand Eight Hundred Pesos (₱ 5,602,800.00)**; and,
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
