

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF  
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING  
APPROVAL**

**Resolution No. GS2025-053  
Series of 2025.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Generator Set which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 23 July 2025 to 11 August 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is Eleven Million Nine Hundred Seventy Thousand Pesos (₱ 11,970,000.00);

**WHEREAS**, in response to the said advertisement, three (3) suppliers/contractors purchased bid documents and submitted its bid, they are, **MNJ Trading, Meganess Pharma Mktg. and Powerarc Industrial Machinery Corp.**;

**WHEREAS**, the bidders' technical component of the bid, including the eligibility requirements were submitted on 12 August 2025. MNJ Trading was able to satisfy the requirements to participate. However, Meganess Pharma Mktg. failed to submit its Income Tax Return for 2023, while Powerarc Industrial Machinery Corp. failed to include in its financial component the Instructions to Bidder and Financial Bid Form. Hence, applying the pass/fail criteria, both bidders were declared disqualified to participate in the activity;

**WHEREAS**, the bid proposal of MNJ Trading was found to be substantially complying, subsequently, bid evaluation was conducted and resulted as follows:

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that MNJ Trading appears to be the single calculated bid for the Supply and Delivery of Generator Set, in the amount of Eleven Million One Hundred Fifteen Thousand Pesos (₱ 11,115,000.00);

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by MNJ Trading, the documents passed the post-qualification conducted after the bid
