## Resolution No. <u>GS2025-061</u> Series of 2025.

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Grasscutter which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 24 July 2025 to 12 August 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

**WHEREAS**, in response to the said advertisement, five (5) suppliers/contractors purchased bid documents and submitted their bids, they are, GRJC Agri Industrial Machineries, Powerarc Industrial Machinery Corp., Jac-B Construction and General Merchandise, Universal Commercial Corp., and MNJ Trading;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 13 August 2025. Powerarc Industrial Machinery Corp., Universal Commercial Corp., and MNJ Trading were able to satisfy the requirements to participate. However, Jac-B Construction and General Merchandise failed to submit its VAT payment for the 2<sup>nd</sup> quarter from bid opening and GRJC Agri Industrial Machineries failed to submit its Single Largest Completed Contract. Hence, applying the pass/fail criteria, were declared disqualified to participate in the activity;

**WHEREAS**, the bid proposal of Powerarc Industrial Machinery Corp., Universal Commercial Corp., and MNJ Trading were found to be substantially complying, subsequently, bid evaluation was conducted and resulted as follows:

- 1. TO DECLARE POWERARC INDUSTRIAL MACHINERY CORP. as the bidder with the lowest calculated and responsive bid for the Supply and Delivery of Grasscutter in the amount of Two Million Nine Hundred Fifty Six Thousand Five Hundred Pesos (\$\mathbb{P}\$ 2,956,500.00); and,
- 2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
