WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Basketball and Volleyball for distribution in line with the different sports development program and other activities of Rizal Province which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 04 February 2026 to 23 February 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Five Million Three Hundred Fifty Thousand Pesos (₱ 5,350,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor submitted its bid, that is, Jetster Enterprises;

WHEREAS, the bidder’s technical component of the bid, including the eligibility requirements were submitted on 24 February 2026 and thereafter found to be eligible;

WHEREAS, the bidder’s financial component of the bid was found to be substantially complying;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED the following:




