

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2026-028
Series of 2026.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Mini Dump Truck for use of Rizal Provincial Government which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 13 February 2026 to 04 March 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is Ten Million Five Hundred Thousand Pesos (₱ 10,500,000.00);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors submitted its bid documents namely MCX International, Inc. and Swift Global Marketing Corp.;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 05 March 2026. MCX International Inc. was able to satisfy the requirements to participate. However, Swift Global Marketing Corp. failed to submit its Business Tax Returns for the last two (2) quarters of 2025 (July to September 2025 and October to December 2025). Hence, applying the pass/fail criteria, Swift Global Marketing Corp. was declared disqualified to participate in the activity;

WHEREAS, the bid proposal of MCX International Inc. was found to be substantially complying, subsequently, bid evaluation was conducted and resulted as follows:

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that MCX International Inc. appears to be the single calculated and responsive bid for the Supply and Delivery of Mini Dump Truck, in the amount of Nine Million Seven Hundred Twenty Thousand Pesos (₱ 9,720,000.00);


WHEREAS, upon careful examination, validation and verification of the requirements, to

2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


UNANIMOUSLY APPROVED this 10th day of March 2026, at the City of Antipolo, Province of Rizal.


