WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Mini-Dump Truck for the use of Rizal Provincial Government which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 29 April 2026 to 19 May 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is Six Million Three Hundred Thousand Pesos (₱ 6,300,000.00);

WHEREAS, in response to the said advertisement, three (3) suppliers/contractors submitted their bid documents, namely, JAC Automobile Int'l Phils. Inc., MCX International Inc., and Autokid Mobility Solutions Philippines, Inc;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 20 May 2026 and thereafter found to be eligible;

WHEREAS, the bidders' financial component of the bid was found to be substantially complying;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:

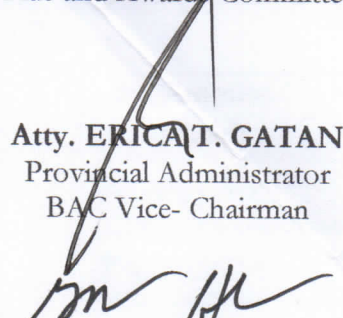

2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.

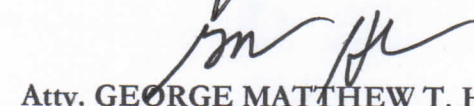

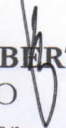
