

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2026-040
 Series of 2026.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of Passenger Van for the use of Rizal Provincial Government which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 29 April 2026 to 19 May 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is Six Million Pesos (₱ 6,000,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor submitted its bid documents, namely, Toyota Taytay Rizal, Inc. ;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 20 May 2026;

WHEREAS, the bid proposal of Toyota Taytay Rizal, Inc. was found to be substantially complying, subsequently, bid evaluation was conducted and resulted as follows:

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by Toyota Taytay Rizal, Inc. the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive.


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED the following, and:
