

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Provision of Food for the 2026 Regional Athletic Association Meet (RAAM) 10-day Live-in Training on February 22 to March 3, 2026 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 30 January 2026 to 17 February 2026 in compliance with RA 12009, otherwise known as New Government Procurement Act and its 2025 Implementing Rules and Regulation (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Four Million Pesos (₱ 4,000,000.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, VND Enterprises;

**WHEREAS**, the bidder’s technical component of the bid, including the eligibility requirements were submitted on 18 February 2026 and thereafter found to be eligible;

**WHEREAS**, the bidder’s financial component of the bid was found to be substantially complying;


**NOW THEREFORE, WE**, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following:



**UNANIMOUSLY APPROVED** this 18<sup>th</sup> day of February 2026, at the City of Antipolo, Province of Rizal.


