WHEREAS, the project title stipulated in the Invitation to Bid has to be corrected to conform and be consistent in the above-mentioned Certificate of Availability of Funds;


WHEREAS, rectifying the project title does not change the project’s Scope of Work and its Bill of Quantities as to what has been indicated in the Bidding Documents;
