Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

A complete set of Bidding Documents may be purchased by any interested Bidders on Dec. 11 - 26, 2016 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of P 5,000.00.

The Rizal Provincial Government will hold a Pre-Bid Conference on **Dec. 13, 2016** at **11:00** am, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **Dec. 27, 2016 until 9:00 am**. All Bids must be accompanied by a bid security in the amount equal to the percentage of the Approved Budget for the Contract in accordance with the form of bid security prescribed herein.
