The Rizal Provincial Government will hold a Pre-Bid Conference on **September 23**, **2016** at **10:00 am**, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **October 11, 2016 until 9:00 am**. All Bids must be accompanied by a bid security in the amount equal to the percentage of the Approved Budget for the Contract in accordance with the form of bid security prescribed herein.
