Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

The Rizal Provincial Government will hold a Pre-Bid Conference on **March 6, 2017** at **2:00 pm**, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before March 21, 2017 until 1:00 pm. All Bids must be accompanied by a bid security in the amount equal to the percentage of the Approved Budget for the Contract in accordance with the form of bid security prescribed herein.
