Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

A complete set of Bidding Documents may be purchased by any interested Bidders on **June 14 – July 4, 2017** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 5,000.00**.

The Rizal Provincial Government will hold a Pre-Bid Conference on **June 22, 2017** at **11:00 am**, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **July 5, 2017 until 1:00 pm**. All Bids must be accompanied by a bid security in the amount equal to the percentage of the Approved Budget for the Contract in accordance with the form of bid security prescribed herein.
