The Rizal Provincial Government will hold a Pre-Bid Conference on **June 28, 2017** at 2:00 pm, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **July 12, 2017 until 1:00 pm**. All Bids must be accompanied by a bid security in the amount equal to the percentage of the Approved Budget for the Contract in accordance with the form of bid security prescribed herein.

Bid opening shall be on **July 12, 2017** at 2:00 pm. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
