To bid for the aforementioned contract, a contractor must purchase bid documents and must meet the following major criteria (a) Filipino citizen or 75% Filipino - owned partnership, corporation, cooperative, or joint venture, (b) with PCAB license applicable to the type and cost of this contract, (c) completion of a similar contract costing at least 50% of ABC within a period of 10 years, and (d) Net Financial Contracting Capacity at least equal to ABC, or credit line commitment at least equal to 10% of ABC. The BAC will use non-discretionary pass / fail criteria in the eligibility check and preliminary examination of bids.
