RESOLUTION ADJUSTING THE DATE OF ISSUANCE OF BID DOCUMENTS, SUBMISSION OF BIDS, AND OPENING OF BIDS FOR THE INVITATION TO BID TO BE PUBLISHED FROM 16 FEBRUARY 2023 TO 22 FEBRUARY 2023
