**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of two (2) units Mobile Kitchen which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website, and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Rizal Provincial Hospital-Morong Main and Ynares Sports Arena for the period covered 18 November 2020 to 7 December 2020, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P6,840,000.00;

**WHEREAS**, in response to the said advertisement, only one (1) bidder/supplier purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical and eligibility documents were submitted on 9 December 2020 where bidder was thereafter found to be eligible;

**WHEREAS**, the bid proposal of the bidder was found to be substantially complying;

2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


