**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Gardening Tools which was posted in the Philippine Government Electronic Procurement System (PhilGEPs) and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 5 August 2021 to 24 August 2021 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P1,940,580.00;

**WHEREAS**, in response to the said advertisement, one (1) contractor/supplier purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical and eligibility documents were submitted on 25 August 2021 where bidder was thereafter found to be eligible;

**WHEREAS**, the bid proposal of the bidder was found to be substantially complying;


**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
