WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of two (2) units 6 Wheeler Mini Dump Truck which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website, and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Rizal Provincial Hospital-Morong Main and Ynares Sports Arena for the period covered 8 April 2021 to 28 April 2021, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P6,000,000.00;

WHEREAS, in response to the said advertisement, only one (1) bidder/supplier purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical and eligibility documents were submitted on 29 April 2021 where bidder was thereafter found to be eligible;

WHEREAS, the bid proposal of the bidder was found to be substantially complying;


