WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid for the purchase of Food Commodities which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Ynares Sports Arena and Ynares Sports Center for the period covered 02 December 2021 to 22 December 2021 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P20,100,000.00 or P140.00/3 meals/per patient/per day;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 22 December 2021 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;
