

BIDDING & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of 5,000 pcs Tablet Armchair which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Rizal Provincial Hospital-Morong Main and Ynares Sports Center for the period covered 19 January 2021 to 09 February 2021 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P4,000,000.00;

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 9 February 2021. Two (2) bidders were able to satisfy the requirements to participate namely, Ed-Val Enterprises and Base Wood Product;

WHEREAS, the bidders' financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Ed-Val Enterprises appears to be the lowest calculated bid for the purchase of 5,000 pcs Tablet Armchair in the total amount of P 3,590,000.00;

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical components including the eligibility requirements and financial components of the bid submitted by the bidder, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. **TO DECLARE Ed-Val Enterprises** as the bidder with the lowest calculated and responsive bid for the supply and delivery of 5,000 pcs. Tablet Armchair in the total amount of P3,590,000.00; and
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
