

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2021 - 104
Series of 2021.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of LT. Equipment for the use of the Provincial Engineering Office which was posted in the Philippine Government Electronic Procurement System (PhilGEPs) and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Ynares Sports Center and Ynares Sports Arena for the period covered 29 September 2021 to 19 October 2021, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its Revised Implementing Rules and Regulations;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P1,178,700.00;

WHEREAS, in response to the said advertisement, one (1) contractor/supplier purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 21 October 2021 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


1. **TO DECLARE EMFERYORK TRADING** as the bidder with the single calculated and responsive bid for the purchase of I.T. Equipment in the amount of **₱1,168,000.00**; and
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




