

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE
DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID
AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2021-129-C
Series of 2021**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of School Bags (Elementary and High School) for distribution to different schools in Montalban Rizal CY 2022 and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 6 December 2021 to 24 December 2021, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, in response to the said advertisement, two (2) contractors/suppliers purchased bid documents and submitted its bid;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P25,930,200.00;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 27 December 2021 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, **Redd Trading**, submitted in the amount of P25,638,370.00; and **Green Energy Trading** submitted quotation in the amount of P 25,590,192.00;

WHEREAS, the bid proposal of the bidder was found to be substantially complying;

1. **TO DECLARE GREEN ENERGY TRADING** as the bidder with the lowest calculated and responsive bid for the supply and delivery of School Bags (Elementary and High School) for distribution to different schools in Montalban Rizal CY 2022 in the amount of P 25,590,192.00; and
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
