WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Medical Supplies (Consumables for Mechanical Ventilator) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center and Ynares Sports Arena for the period covered 27 May 2021 to 15 June 2021 in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P1,896,500.00;

WHEREAS, in response to the said advertisement, only one (1) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 16 June 2021 and were thereafter found to be eligible;

WHEREAS, the bid proposal of the bidder was found to be substantially complying;
