WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of fifteen (15) units Patrol Vehicle 4x4 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website, and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Rizal Provincial Hospital System-Morong and Ynares Sports Complex for the period covered 26 November 2021 to 15 December 2021, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P24,000,000.00;

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid, namely, MCX International, Inc. and Agrani Motors, Inc.;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 16 December 2021 and only one (1) bidder, MCX International, Inc., was thereafter found to be eligible;

WHEREAS, the BAC no longer proceeded with the opening of the bid documents of the second bidder, Agrani Motors, Inc. The aforementioned bidder submitted its bid documents at 1:35 p.m. which is five (5) minutes late than the specified time indicated in the Invitation to Bid which is 1:30 p.m.

WHEREAS, the bid proposal of the bidder was found to be substantially complying;

1. **TO DECLARE MCX INTERNATIONAL, INC.** as the bidder with the single calculated and responsive bid for the purchase of fifteen (15) units Police Patrol Vehicle 4x4 in the total amount of **₱23,250,000.00**;
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
