**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of School Supplies for the distribution to different schools in Montalban Rizal for CY 2022 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website, and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Sports Center and Ynares Sports Arena for the period covered 6 December 2021 to 24 December 2021, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P19,044,810.00;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical component of the bid, including the eligibility requirements were submitted on 27 December 2021 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


