

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2021-095
Series of 2021**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Medical Supplies which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 2 September 2021 to 22 September 2021, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P13,899,737.50;

WHEREAS, in response to the said advertisement, six (6) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 23 September 2021 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, Nemrac Medical & Pharma Supplies Corporation submitted quotation for Item Nos. 1-31, 33-75, 77 and 78 in the amount of P 13,666,696.90, Patient Care Corporation submitted quotation for Item Nos. 1-9, 14-16, 18-28, 30-39, 41-43, 46, 50-53, 61-74, 77 and 78 in the amount of P 9,731,784.05, Medalert Enterprises submitted quotation for Item Nos. 1-10, 13-31, 38-47, 50-55 and 59-78 in the amount of P 9,535,336.50, Blu Enterprises submitted quotation for Item Nos. 1-2, 5, 7-10, 13, 15-16, 18-29, 38-42, 62, 63 44-47, 50-53, 59, 60, 64, 66, 72-74 and 76-78 in the amount of P 6,813,121.40, Medical Center Trading Corporation submitted quotation for Item Nos. 7, 10, 33, 35-39, 46, 51-52, 61 and 67-70 in the amount of P 4,989,153.50 and Rite-Tech Marketing submitted quotation for Item Nos. 11-12, 48-49, 53, 56-58 and 74-76 in the amount of P 1,715,450.00;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, when the submitted bids were evaluated, **Patient Care Corporation** submitted quotation for Item Nos. 32, 67-70 and 72-73 in the amount of P1,242,722.50, **Medalert Enterprises** submitted quotation for Item Nos. 1, 3, 5, 16, 23, 30, 54-55, 61-63, 65 and 71 in the amount of P1,445,746.00, **Rite-Tech Marketing** submitted quotation for Item Nos. 11-12, 48-49, 56-58 and 76 in the amount of P 1,580,964.25, **Nemrac Medical & Pharma Supplies Corporation** submitted quotation for Item Nos. 2, 4, 6-9, 13-14, 17, 31, 34, 41-43 and 75 in the amount of P 1,696,105.25, **Medical Center Trading Corporation** submitted quotation for Item Nos. 33, 35, 36 and 37 in the amount of P 1,902,408.00 and **Blu Enterprises** submitted quotation for Item Nos. 10, 15, 18-29, 24-29, 38-40, 44-47, 50-53, 59-60, 64, 66, 74, 77 and 78 in the amount of P5, 363,943.80,

2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


