WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P13,318,879.94;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 22 March 2021 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid were found to be substantially complying;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




