

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE
 DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID
 AND ITS RECOMMENDING APPROVAL**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of eleven (11) units Mini Dump Truck (Brand New w/Printed Logo) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 1 July 2021 to 21 July 2021, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P18,700,000.00;

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 21 July 2021 and was thereafter found out that only one (1) bidder that is Powertrac Incorporated complied with the requirements;

WHEREAS, Solid Machinery & Diesel Parts, Inc. having been failed to submit their Single Largest Completed Contract was declared Disqualified to participate in the bidding;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that **Powertrac Incorporated** appears to be the single calculated bid for the purchase of eleven (11) units Mini Dump Truck (Brand New w/Printed Logo) in the amount of P 18,480,000.00;

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical components including the eligibility requirements and financial components of the


bid submitted by the winning bidder, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. **TO DECLARE POWERTRAC INCORPORATED** as the bidder with the single calculated and responsive bid for the purchase of eleven (11) Units Mini Dump Truck (Brand New w/Printed Logo) in the total amount of **₱ 18,480,000.00**;
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
