**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is P3,360,000.00;

**WHEREAS**, in response to the said advertisement, only one (1) bidder/supplier purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical and eligibility documents were submitted on 18 August 2021 where bidder was thereafter found to be eligible;

**WHEREAS**, the bid proposal of the bidder was found to be substantially complying;
