WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the Provision of Hospital Linens and Laundry Services which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Sports Complex and Ynares Sports Arena for the period covered 02 December 2021 to 22 December 2021 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P7,000,000.00 or P50.00/kilo;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 22 December 2021 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;
