

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL.**

**Resolution No. GS2022-019

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid for the contract for the Hiring of Janitorial Services for Rizal Provincial Hospital System – Ynares Municipal Hospital in the Philippine Government Electronic Procurement System (PhilGEPS), and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Rizal Provincial Hospital-Morong Main and Ynares Sports Center for the period covered 04 February 2022 to 22 February 2022, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱ 800,000.00;

**WHEREAS**, in response to the said advertisement, two (2) supplier/contractor purchased bid documents and but only one (1) supplier/contractor submitted its bid and that is, Cleanermen, Inc.;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 23 February 2022 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Cleanermen, Inc. appears to be the single calculated bid for the contract of Hiring of Janitorial Services for Rizal Provincial Hospital System – Ynares Municipal Hospital in the amount of ₱ 790,770.30;

**WHEREAS**, the new contract with the winning bidder, that is Cleanermen, Inc., will be for a period of ten (10) months only from 01 March 2022 to 31 December 2022.

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;



2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


