WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Medical Supplies which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, RPHS-Angono and RPHS-Morong for the period covered 3 June 2022 to 22 June 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱16,900,000.00;

WHEREAS, in response to the said advertisement, three (3) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 23 June 2022 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, Rite-Tech Marketing submitted quotation for Item Nos. 1, 2, 3 and 4 in the bid amount of ₱ 16,620,000.00, Dynamed Healthcare, Inc. submitted quotation for Item Nos. 1 and 3 in the bid amount of ₱ 8,097,998.00 and Medmaster, Inc. submitted quotation for Item Nos. 1 and 2 in the bid amount of ₱ 6,880,000.00;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid;

WHEREAS, when the submitted bids were evaluated, **Medmaster, Inc.** submitted quotation for Item No. 2 in the amount of ₱ 3,590,000.00, **Dynamed Healthcare Inc.** submitted quotation for Item No. 1 in the amount of ₱3,199,998.00, and **Rite-Tech Marketing** submitted quotation for Item Nos. 3 and 4 in the amount of ₱9,700,000.00.

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:

1. TO DECLARE:

- 1.1 **MEDMASTER, INC'S** quotation for **Item No. 2** in the amount of **₱ 3,590,000.00;**
- 1.2 **DYNAMED HEALTHCARE INC.'s** quotation for **Item No. 1** in the amount of **₱3,199,998.00;**
- 1.3 **RITE-TECH MARKETING's** quotation for **Item Nos. 3 and 4** in the amount of **₱ 9,700,000.00.**






2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


