WHEREAS, the detailed evaluation of the bid conducted after the opening of bid;

WHEREAS, when the submitted bids were evaluated, Medmaster, Inc. submitted quotation for Item No. 2 in the amount of ₱ 3,590,000.00, Dynamed Healthcare Inc. submitted quotation for Item No. 1 in the amount of ₱3,199,998.00, and Rite-Tech Marketing submitted quotation for Item Nos. 3 and 4 in the amount of ₱9,700,000.00.
