**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the Provision of Food Meal for Mega Vaccination and Mega Swabbing Facility at Ynares Event Center, Primark Montalban, Rizal, and Rizal Provincial Capitol which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 24 January 2022 to 15 February 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱ 1,810,900.00;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 15 February 2022 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;



**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


1. **TO DECLARE EDCT Food Services** as the bidder with the single calculated and responsive bid for the Provision of Food;
