

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**Resolution No. GS2022- 070**

**Series of 2022**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Fourteen (14) Units of Prisoner's Van which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, RPHS-Angono and RPHS-Morong for the period covered 17 June 2022 to 07 July 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱22,400,000.00;

**WHEREAS**, in response to the said advertisement, three (3) suppliers/contractors purchased bid documents and submitted its bid;

**WHEREAS**, the bidder's technical component of the bid, including the eligibility requirements were submitted on 08 July 2022. One (1) of the supplier, Citimotors Inc., failed to submit their Income Tax Return (ITR) and Financial Statement for the year 2020 and their Manpower requirement, hence, was declared disqualified to participate in the activity;

**WHEREAS**, two (2) suppliers/contractors was thereafter found to be eligible, that is, Elite North Autocars, Inc. and MCX International, Inc.;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

**WHEREAS**, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Elite North Autocars Inc. appears to be the lowest calculated bid for the purchase of Fourteen (14) units of Prisoner's Van in the amount of ₱ 19,348,000.00;

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

**NOW THEREFORE**, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. **TO DECLARE ELITE NORTH AUTOCARS INC.** as the bidder with the lowest calculated and responsive bid for the purchase of Fourteen (14) units Prisoner's Van;
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
