WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Diploma Holder with Wooden Substrate which was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Sports Center and Ynares Sports Arena for the period covered 25 March 2022 to 15 April 2022 compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P25,256,000.00;

WHEREAS, in response to the said advertisement, one (1) contractor/supplier purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical and eligibility documents were submitted on 18 April 2022 where bidder was thereafter found to be eligible;

WHEREAS, the bid proposal of the bidder was found to be substantially complying;



NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


