

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2022-039
Series of 2022**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Medical Supplies which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol, Ynares Center Complex and Ynares Sports Arena for the period covered 4 March 2022 to 23 March 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P34,030,197.00;

WHEREAS, in response to the said advertisement, nine (9) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 24 March 2022 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;
