WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Laboratory supplies which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS-Angono and RPHS-Morong for the period covered 04 August 2022 to 23 August 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is P13,022,455.00;

WHEREAS, in response to the said advertisement, four (4) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the Opening of Bids was rescheduled on 25 August 2022 due to inclement weather caused by Severe Tropical Storm "Florita" and as per declaration of work suspension by the President, Ferdinand Marcos Jr. in the affected areas including the Province of Rizal;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 25 August 2022 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, Medical Center Trading Corp. submitted quotation for Item Nos. 1, 2, 4-6, 9-12, 14, 16-24, 30-32, 33, 34, 39, 40, and 56-58 in the amount of \mathbb{P} 5,980,920.00, Nemrac Medical and Pharma Supplies Inc. submitted quotation for Item Nos. 1, 2, 4, 6, 8-13, 19, 22-24, 28-32, 33, 34, 38-40, and 57 in the amount of \mathbb{P} 5,863,178.00, Scientific Biotech Specialties, Inc. submitted quotation for Item Nos. 35-37 and 41-55 in the amount of \mathbb{P} 3,616,800.00, and Allied Hospital Supply International Corp. submitted quotation for Item Nos. 5, 6, 8, 15, 28, 29, 32, and 38 in the amount of \mathbb{P} 2,372,500.00;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, in the quotation submitted by the bidders, NO BID was received on Item Nos. 3, 7, 25-27 (5 line item) in the total amount of ₱ 24,850.00 based on the costs stated in the Invitation to Bid;

WHEREAS, when the submitted bids were evaluated, Medical Center Trading Corp. submitted quotation for Item Nos. 2, 11, 12, 14, 16-18, 20-22, 24, 30, 33, 34, 39, 40, and 56-58 in the amount of $\mathbb{P}1,114,570.00$, Allied Hospital Supply International Corp. submitted quotation for Item Nos. 5, 6, 8, 15, 28, 29, 32, and 38 in the amount of $\mathbb{P}2,192,500.00$, Nemrac Medical and Pharma Supplies Corp. submitted quotation for Item Nos. 1, 4, 9, 10, 13, 19, 23, and 31 in the amount of $\mathbb{P}2,851,570.00$ and Scientific Biotech Specialties, Inc. submitted quotation for Item Nos. 35-37 and 41-55 in the amount of $\mathbb{P}3,616,800.00$, and appears to be the lowest calculated bid

 - 1.3 NEMRAC MEDICAL AND PHARMA SUPPLIES CORP.'s quotation for Item Nos. 1, 4, 9, 10, 13, 19, 23, and 31 in the amount of ₱2,851,570.00; and
 - 1.4 SCIENTIFIC BIOTECH SPECIALTIES, INC.'s quotation for Item Nos. 35-37 and 41-55 in the amount of ₱3,616,800.00.
