

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE
RECOMMENDATION OF THE AWARD OF CONTRACT TO PETRON
CORPORATION FOR THE SUPPLY OF FUEL THROUGH FLEET CARD FACILITY
UNDERTAKEN THROUGH NEGOTIATED PROCUREMENT**

**Resolution No. GS2022 - 032 -A
Series of 2022.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the Negotiated Procurement for the Supply of Fuel through Fleet Card Facility which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, Ynares Sports Center and Ynares Sports Arena for the period covered 21 February 2022 to 28 February 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, an Invitation to Bid (ITB) for the Supply of Fuel through Fleet Card Facility in the amount of Sixteen Million Six Hundred Eighty Six Thousand Pesos (Php 16,686,000.00) was posted last 02 December 2021, however, no bidder submitted their bidding documents on the scheduled Opening of Bids on 22 December 2021;

WHEREAS, the BAC declared the first failure of bidding for the Supply of Fuel through Fleet Card Facility pursuant to BAC Resolution No. GS2021-124 Series of 2021;

WHEREAS, the Approved Budget for the Contract for the Supply of Fuel through Fleet Card Facility - Rebidding amounting to Sixteen Million Six Hundred Eighty Six Thousand Pesos (Php16,868,000.00) was adjusted to Thirteen Million Nine Hundred Five Thousand Pesos (Php13,905,000.00);

WHEREAS, a second Invitation to Bid for the Supply of Fuel through Fleet Card Facility was posted and the opening of bids was scheduled on 10 February 2022, however, no bidder submitted their bids;

WHEREAS, Resolution No. GS2022 - 015 Series of 2022 was issued declaring a 2nd Failure of Bidding and the Recommendation to enter into a Negotiated Procurement for the Supply of Fuel through Fleet Card Facility;

WHEREAS, a letter of Invitation for Negotiated Procurement for the Supply of Fuel through Fleet Card was sent to three (3) petroleum companies;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB for Negotiated Procurement was adjusted to P13,209,750.00 from Php 13,905,000.00;

WHEREAS, the Bids and Awards Committee conducted a meeting under Negotiated Procurement for the Supply of Fuel through Fleet Card Facility with all interested bidders on 2 March 2022;

WHEREAS, in response to the said advertisement, only one (1) supplier/contractor attended the meeting and later on purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 9 March 2022 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid were found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Petron Corporation. appears to be the single calculated and responsive bid for the Supply of Fuel through Fleet Card Facility through Negotiated Procurement in the amount of P13,209,750.00.


WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical components including the eligibility requirements and financial components of the bid submitted by the bidder, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


1. TO DECLARE PETRON CORPORATION as the bidder with the single calculated and responsive bid for the Supply of Fuel through Fleet Card Facility through Negotiated Procurement in the amount of P 13,209,750.00; and
2. TO RECOMMEND for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
