BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE LOWEST CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2022- 093
Series of 2022**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the purchase of Medical Supplies for COVID-19 operations for hospitals under the Rizal Provincial Hospital System for 2nd Semester 2022 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS - Angono and RPHS - Morong for the period covered 10 August 2022 to 29 August 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱2,606,550.00;

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 30 August 2022 and thereafter found to be eligible;

WHEREAS, the other bidder's financial component of the bid was found to be substantially complying;

WHEREAS, when the submitted bids were read, it appears that, Infinite Medical Trading submitted quotation for Item Nos.1-6 in the amount of ₱ 2,564,920.00 and Bio-Fil Pharma Marketing Corporation submitted quotation for Item Nos. 1-6 in the bid amount of ₱ 2,563,995.00

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid;

WHEREAS, when the submitted bids were evaluated, Bio-Fil Pharma Marketing Corporation submitted quotation for Item Nos. 1-3 and 5 in the amount of ₱ 1,235,835.00 and **Infinite Medical Trading** submitted quotation for Item Nos. 4 and 6 in the amount of ₱1,313,640.00.

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** the following, and:

1. TO DECLARE:

- 1.1 **INFINITE MEDICAL TRADING's** quotation for **Item Nos. 4 and 6** in the amount of **₱ 1,313,640.00**; and
- 1.2 **BIO-FIL PHARMA MARKETING CORPORATION's** quotation for **Item Nos. 1-3 and 5** in the amount of **₱1,235,835.00**;

as the lowest calculated and responsive bid for the supply and delivery of such medical supplies.


2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.






