WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid for the contract for the Hiring of Janitorial Services for Rizal Provincial Capitol Building, Rizal Provincial Capitol Annex, Ynares Event Center and Rizal Provincial Hospital System (Morong, MADMH, Angono, CAYSMH, YMH and Taytay)in the Philippine Government Electronic Procurement System (PhilGEPS), and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Capitol Building, RPHS - Morong and RPHS - Angono for the period covered 02 December 2022 to 22 December 2022, in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱38,370,000.00;

WHEREAS, the Provision for the Hiring of Janitorial Services was on a per lot basis;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and that is, Cleanermen, Inc.;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 22 December 2022 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Cleanermen, Inc. appears to be the single calculated bid for the contract of Hiring of Janitorial Services for RPHS − Angono in the amount of ₱1,666.71/sqm, RPHS − CAYSMH in the amount of ₱1,499.03/sqm, RPHS − MADMH in the amount of ₱1,120.28/sqm, RPHS − Morong in the amount of ₱1,029.24/sqm, and RPHS − YMH in the amount of ₱1,000.95/sqm;

WHEREAS, in the quotation submitted by the bidder, NO BID was received on Lot Item Nos. 1, 2, 3, and 9 with equivalent sum of Approved Budget for the Contract (ABC) in the amount of P13,539,999.99 based on the costs stated in the Invitation to Bid;

WHEREAS, the new contracts with the winning bidder, that is Cleanermen, Inc., shall be for twelve (12) months covering the period from 01 January 2023 to 31 December 2023.

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- 1. TO DECLARE CLEANERMEN, INC. as the bidder with the single calculated and responsive bid for the Hiring of Janitorial Services for Lot Item Nos. 4, 5, 6, 7 and 8, to wit:
 - a.) RPHS Angono in the amount of ₱1,666.71 / sqm;
 - b.) RPHS CAYSMH in the amount of ₱1,499.03 / sqm;
 - c.) RPHS MADMH in the amount of ₱1,120.28 / sqm;
 - d.) RPHS Morong in the amount of ₱1,029.24 / sqm; and
 - e.) RPHS YMH in the amount of \$\P1,000.95 / sqm;
- 2. That **NO BID** was received for **Lot Item Nos.** 1, 2, 3, and 9 with equivalent sum of Approved Budget for the Contract (ABC) in the amount of ₱13,539,999.99 based on the costs stated in the Invitation to Bid. Thus it has been referred to the BAC members and thereafter decided to re-advertise and re-bid the said items, pursuant to the provisions of RA 9184.
- 3. TO RECOMMEND for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
